



## **QuIP Lead Evaluator Training**

## Schedule: Monday 26<sup>th</sup> February – Monday 4<sup>th</sup> March 2024

Prior to the start date you will be sent:

- A form to complete with more information about you, your work and any planned evaluation where you think you could use QuIP.
- Access to a learning platform which will be used during the course for viewing the materials
- Calendar invites for the live sessions, using Google Meet

This schedule is split into independent study sessions using pre-recorded presentations sent to you and live video-link sessions. You will need to **view the presentations before each live session**, and where possible complete suggested exercises individually or with other training participants. We have broken the course down into days, with both live sessions and independent work outlined for each day. You will need to do some study prior to the first live session, so please ensure that you have time set aside to complete the introductory materials.

There are five live sessions. These are complemented by self-study materials for you to follow in the time between each live session. It is vital that you can commit to the pre-work for each session so please check the schedule carefully.
